 - If you have any questions or want to apply by phone, you can call (or use Video Relay Service) 1-800-621-3362 (answered 7 days/wk, 6am 10pm)
 - There are direct funds as well as disaster-related legal assistance available
 - FEMA has reported 100,000 applications and 26,000 inspections have been completed with 14,000 approvals thus far. FEMA has paid out a little over \$30million so far.
 - Some FEMA personnel *are* going door to door with photo identification and are calling people to help with damage assessments. If you have any questions about legitimate contacts, you can call the FEMA Helpline at 800-621-3362.

 - Please report any damage no matter how minimal to FEMA or via CM Kamin's office you can apply as a homeowner or a renter (for contents, vehicles)
- o Francisco Sanchez, Associate Administrator, Small Business Administration
 - o 16 counties in TX are covered by the current disaster declaration
 - Home owners, renters, and small business owners may apply for <u>assistance</u> through the SBA including loans with low interest rates repayable over 30 years with the first 12 months interest-free:
 - To apply, visit the <u>website</u> or call 1.800.659.2955 (or 711 for accessible access)
 - Up to \$500,000 in loans available for homeowners
 - Up to \$100,000 available for renters
 - Up to \$2 million available for business owners
 - For businesses, if you had a loss of revenue even if the physical structure wasn't damaged you can still qualify for help with rent, payroll, etc.
 - You have up to 9 months to apply for economic injury to a business as a result of the disaster
 - You can still access loans through the SBA even if work has begun already.

- You can apply for a loan and can always decline or only take it partially if you no longer need it.
- o These loans do not count against you on a credit report.
- You can use loan funds to help with mitigation against damage for a future disaster
- Sean Mata Director of External Relations, Daly & Black (Lazybrook Resident) -Presentation on navigating insurance claim process
 - The firm deals primarily with storm damage claims when an insurance company doesn't pay what is needed to restore your home or outright denies a claim
 - There will be a townhall meeting next Tuesday, June 4 at 6:30pm (Covenant Gym, 9200 Hempstead Rd, Ste. 144) for additional help a roofing contractor, attorneys, etc. will be available to answer questions (see flyer)
 - o If you are denied or a claim is undervalued, you can:
 - Walk away
 - Hire a public adjuster
 - Hire an attorney TX law says you can add interest, penalties, and attorney fees in addition to any claim
 - Watch out for contractors who are "storm chasers" in the neighborhood already – look for businesses that are located (and licensed if possible) in Texas
